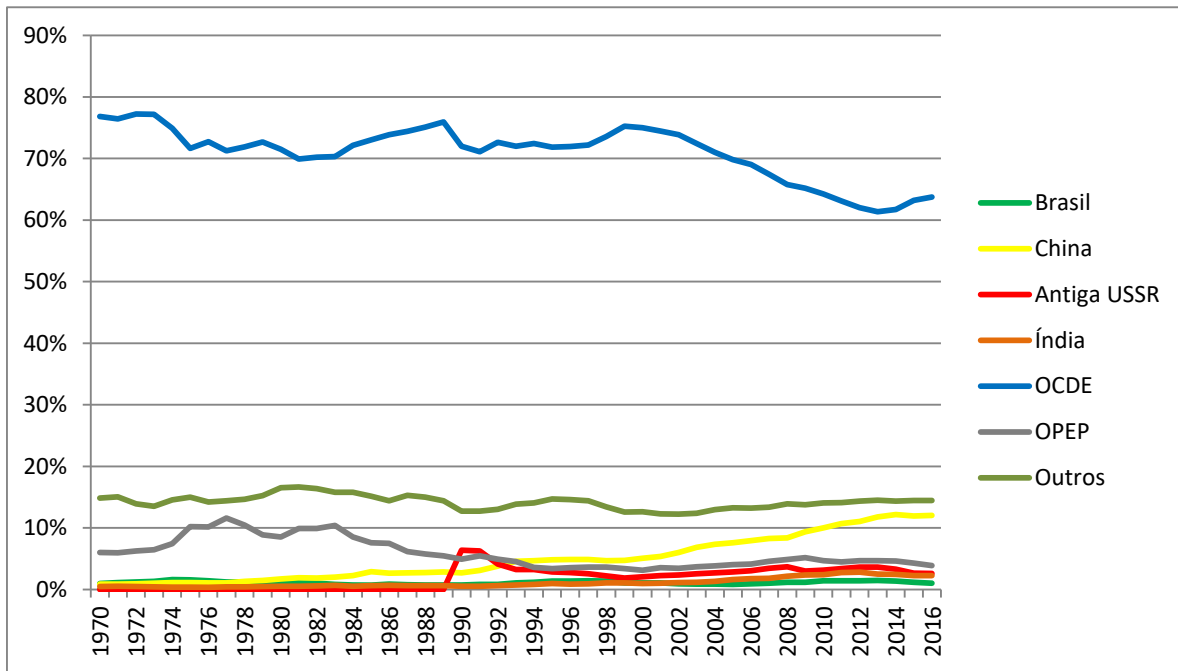

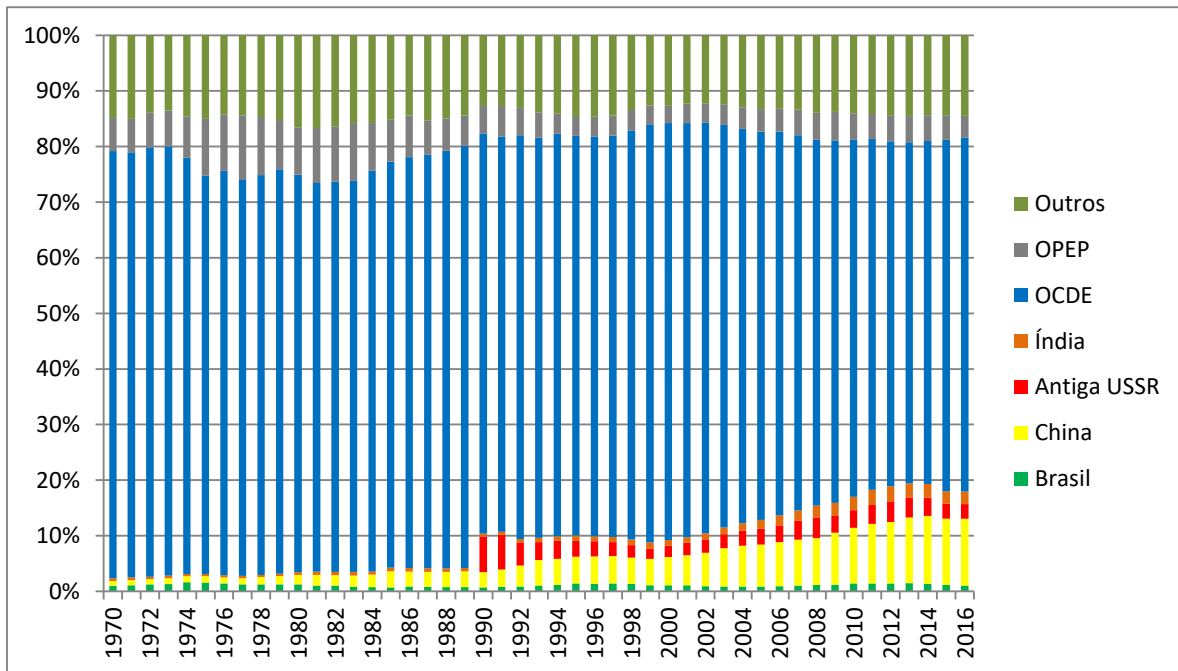
Total regional



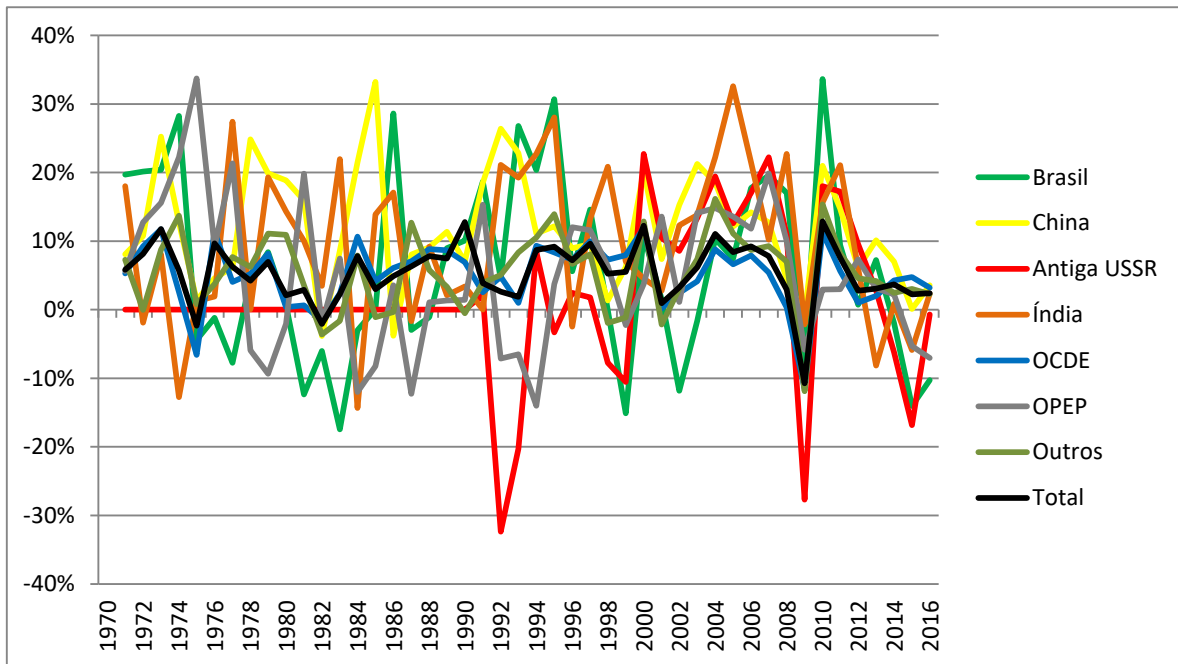
Percentual do total



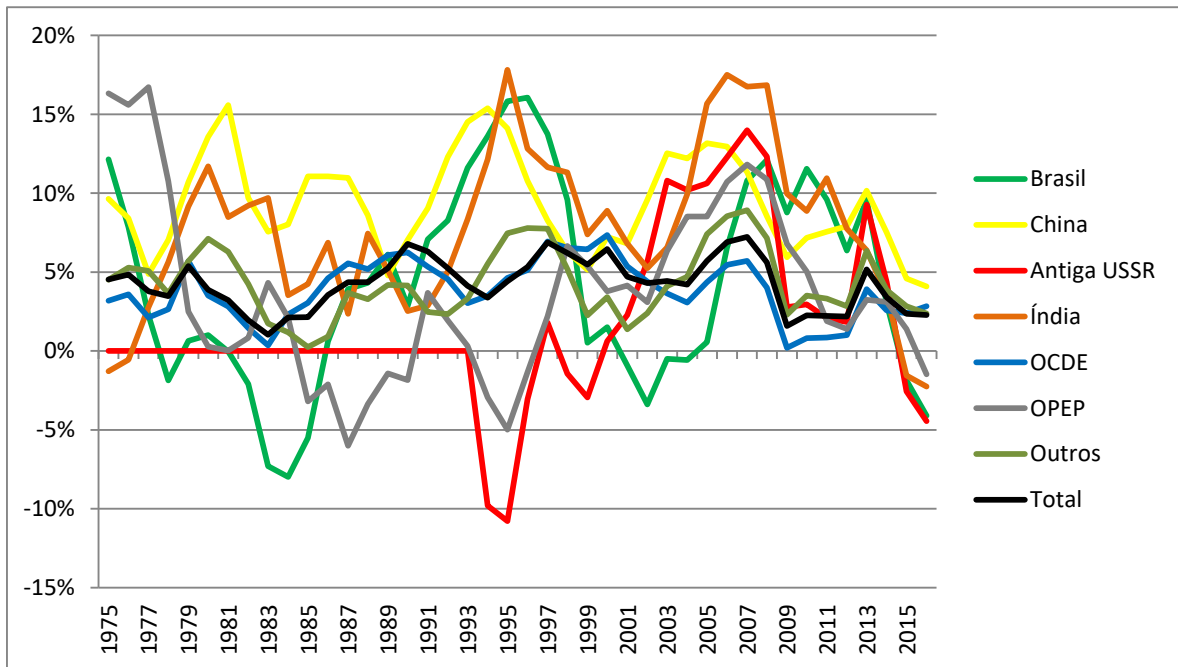
Percentual acumulado



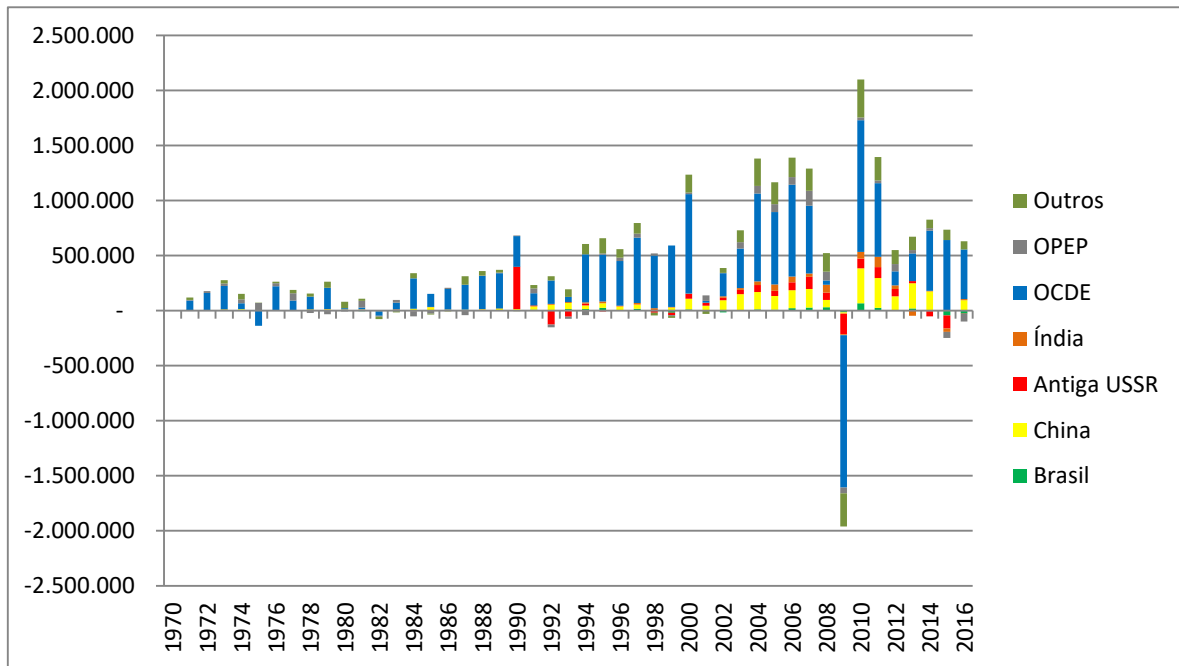
Taxa de crescimento anual



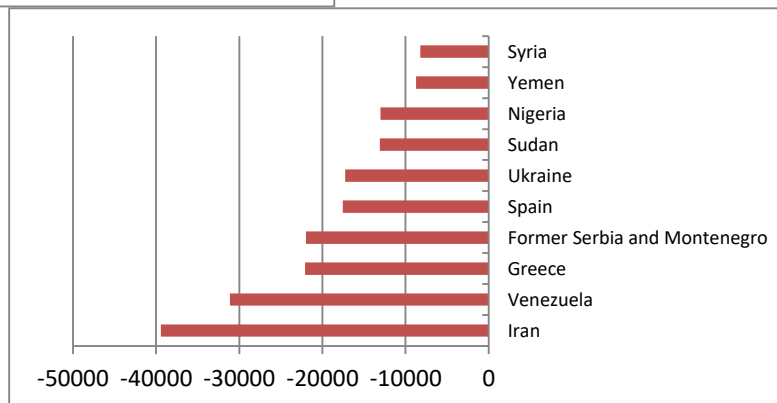
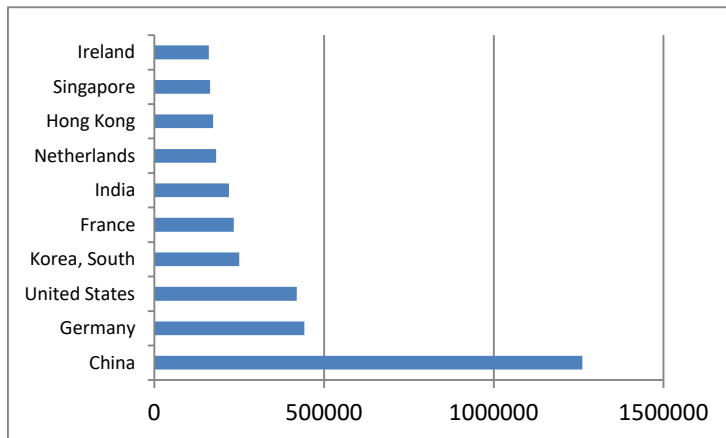
Taxa de crescimento - média móvel de 5 anos



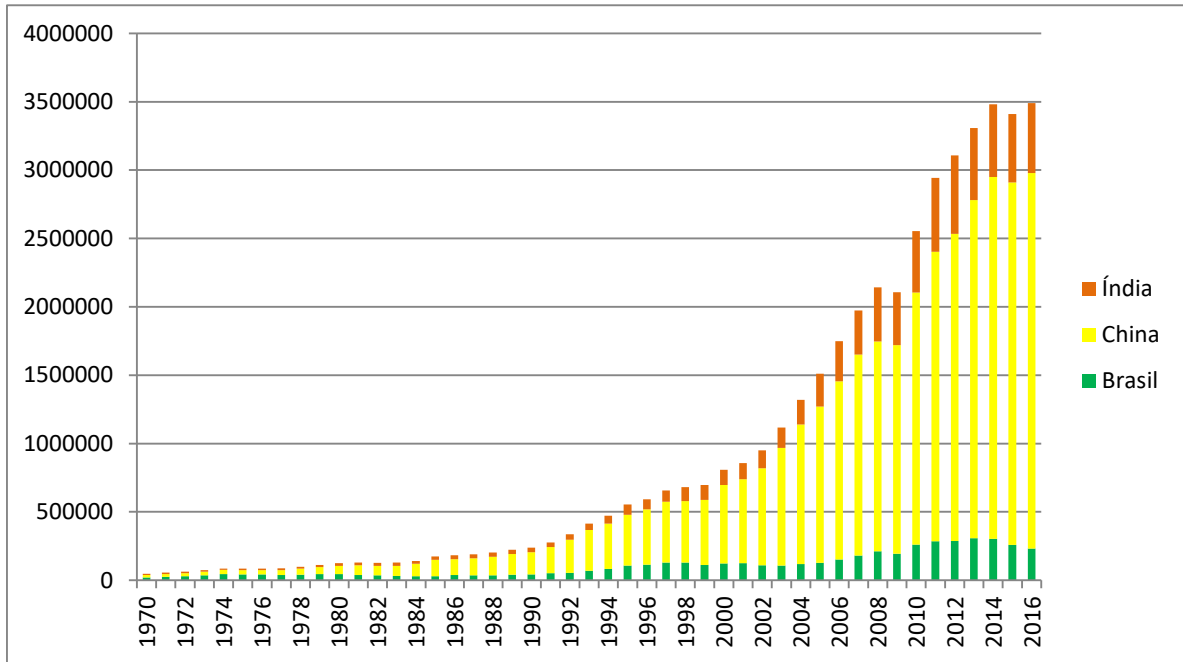
Incremento anual



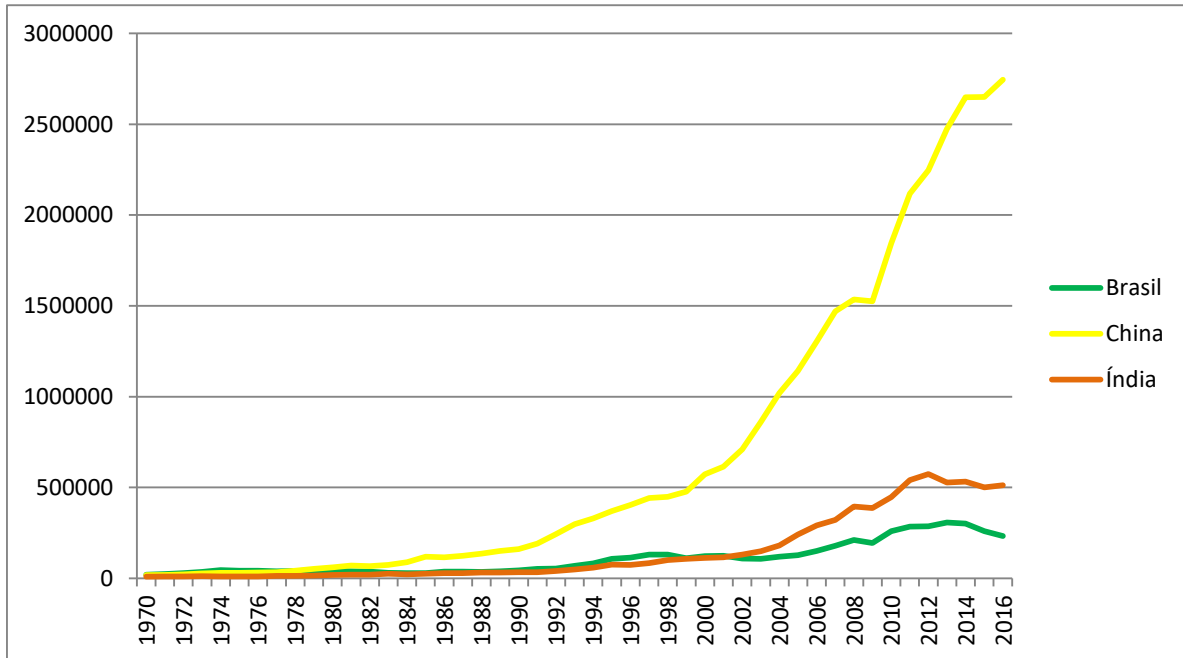
Maiores variações positivas e negativas - últimos 10 anos



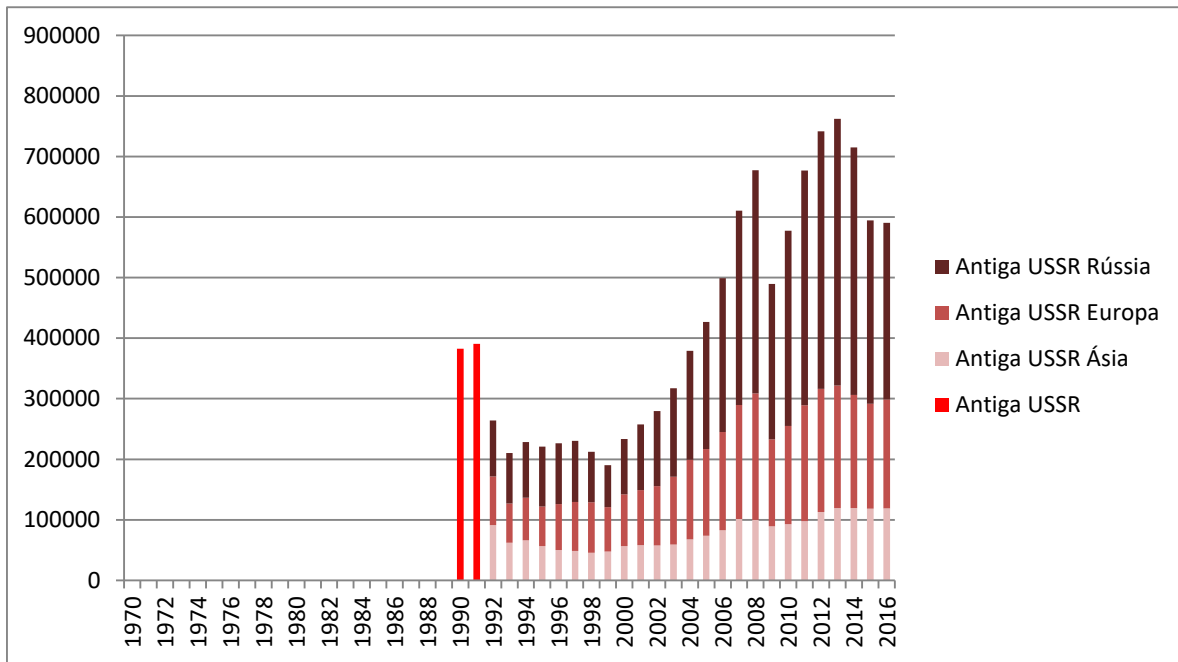

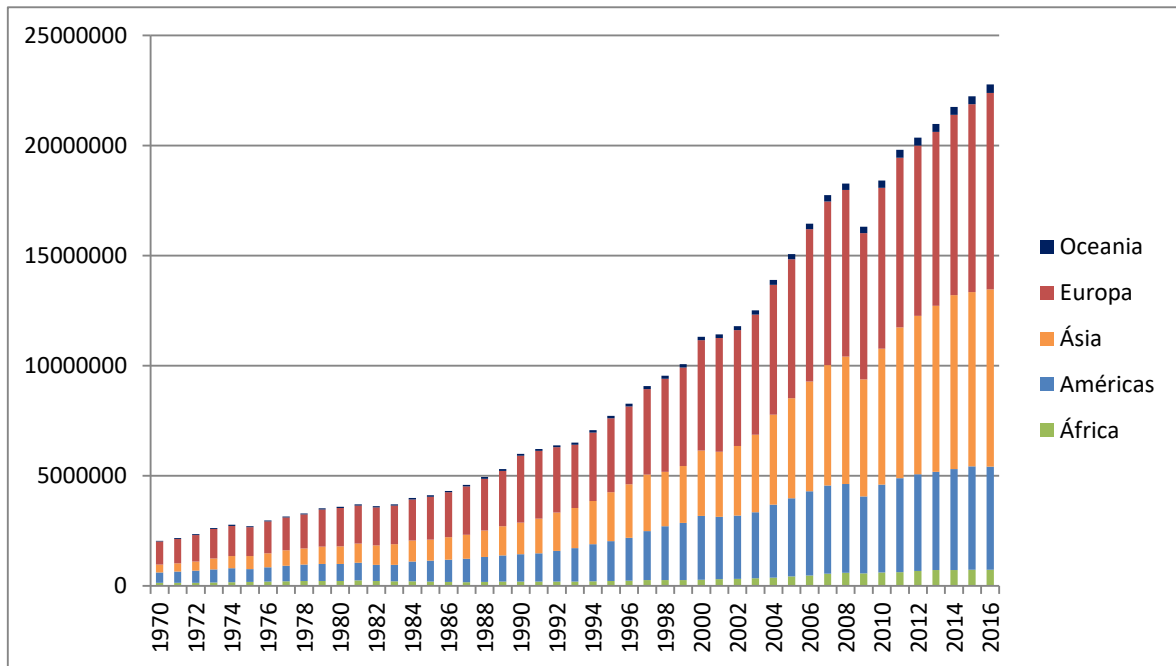

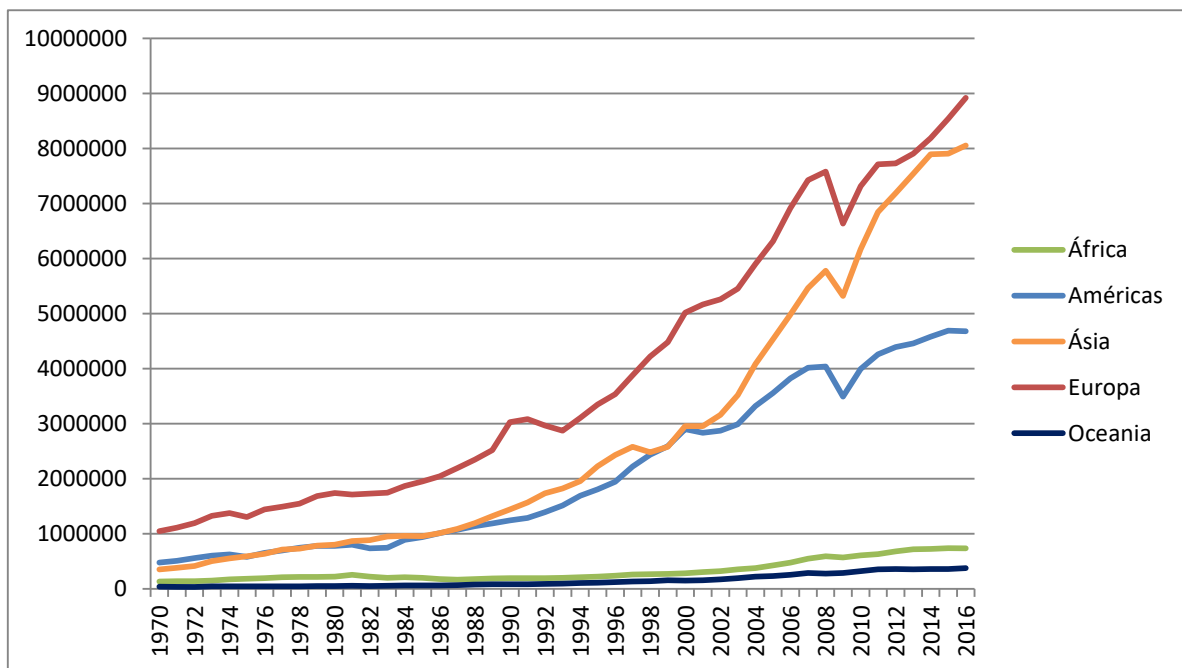
